

## Unaccompanied Minor/Youth Form

An **unaccompanied minor** is a child, who is under 12 years of age and is travelling alone, only with the authority of the parent/guardian. An **unaccompanied youth** is a child, between the ages of 12 and 14 and is travelling alone, only with the authority of the parent/guardian. Children under 5 years will not be accepted for travel unaccompanied. Children over the age of 14 can travel unaccompanied. This form should be completed for both unaccompanied minors and youths.

There should be additional copies made; one copy to be retained by the parent or guardian, one to be held on the ground by the handling agent and one copy to travel with the child (a separate copy for each leg of their journey).

**Declaration:**

I am the parent/guardian of the minor named and as such give permission for him/her to travel unaccompanied.

I confirm that I have made arrangements for the person named; accompanying the minor for departure, will remain at the airport until the flight has departed, and the person named; meeting the minor at the destination or nightstop and/or transfer point, will attend the airport by the scheduled time of arrival of the flight.

Should the minor/youth not be met as stated or in the event of the accompanying adult leaving the Airport prior to departure, I authorise Titan Airways and/or other carriers to take whatever action they consider necessary to ensure the minor's safe custody and comfort including return of the minor/youth to the Airport of departure if necessary. I agree to indemnify and reimburse Titan Airways and/or other carriers for the necessary and reasonable costs and expenses incurred by them in taking such action.

I also agree to indemnify Titan Airways and/or other carriers from and against any damage to their property caused by the minor/youth whilst in their custody.

I certify that the minor/youth is in possession of a valid passport and health certificate (if required) and has any necessary visa(s) for the trip.

I understand that weather or other events may, in rare instances, necessitate an aircraft diversion and/or overnight stay at or away from the point of departure/destination. Some of Titan Airways' taxi and hotel providers require formal, written consent for unaccompanied minor/youth to use their services and/or stay unaccompanied in the hotel. I hereby confirm that I give consent to the unaccompanied minor/youth travelling by taxi unaccompanied and to stay in a hotel room unaccompanied. If the rule of the taxi provider or hotel provider requires that the minor/youth be accompanied, I confirm that I give consent to the minor/youth being accompanied by an employee or representative of Titan Airways. Titan Airways may contact local law enforcement and/or child protection authorities to assist.
